

Khon Kaen University Order No. 8913/2567 (2024)

Subject: Appointment of the Personal Data Control Committee of Khon Kaen University

As Khon Kaen University collects, uses, and discloses personal data, it is necessary to protect such data from any infringement of individual privacy rights, which may cause trouble, annoyance, or damage to the data subject. While still recognizing the necessity of utilizing such personal data in accordance with the objectives of its collection, use, or disclosure, the University must therefore ensure that the processing of personal data by the University complies with the law.

By virtue of the authority under Section 37 (1) of the Khon Kaen University Act, B.E. 2558 (2015), and Clause 9 of the Khon Kaen University Regulation on Personal Data Protection, B.E. 2565 (2022), the following individuals and position holders are hereby appointed to the Personal Data Control Committee of Khon Kaen University, consisting of:

The aforementioned committee shall have the following powers and duties:

- 1. To establish criteria, methods, operational guidelines, or any other procedures to control the collection, use, or disclosure of personal data of Khon Kaen University, in compliance with the Personal Data Protection Act, B.E. 2562 (2019).
- 2. To advise the President on matters concerning the control and protection of personal data.
- 3. To monitor and evaluate the implementation of personal data control by faculties and internal agencies of the University
 - 4. To perform other duties or tasks as assigned by the President.

The committee shall have a term of two (2) years.
